

## **Proposed Amendments**

From Tom Bertolino, KB1P

GARA is applying to IRS for tax exempt status. The application for 501(c) (3) certification is called Form 1023. According to the Instructions for Form 1023 and IRS Publication 557 (Tax-Exempt Status for Your Organization) GARA's current Articles of Incorporation must contain two IRS Requirements to qualify for 501(c)(3) certification. The requirements are:

1. The purpose statement must limit the organization in some way by reference to section 501(c)(3)

2. The organizations' Articles of Incorporation must include a Dissolution Clause.

#### **Regular Meeting Minutes March 24, 2014**

The Greensboro Amateur Radio Association held their monthly meeting on March 24, 2014, at Captain Bills Seafood Restaurant located at 6108 West Market Street in Greensboro.

Vice President Cameron Conover, AJ4TW, called the meeting to order at 7:15 PM. Cameron officiated the meeting for President Tom Bertolino, KB1P who was out of town.

#### **CLUB BUSINESS and OFFICER REPORTS**

Cameron asked that anyone who has any suggestions about presentations for club meetings to please contact him.

Secretary Greg Spencer, KG4UQV, had nothing to report.

Financial officer Todd Smith, AK4TS, said we have a good turnout tonight. Todd reminded everyone that dues are due; Todd said the board is moving along with the PayPal setup and the calendar is up to date on the website. Bob Gusek, NC4RG, will do a presentation on 3D printing at the April meeting.



Operations Chairman Roy Smith, N4BYU, spoke about the Quarter Century Wireless Association and Amateur radio testing. Members present were: President Tom Bertolino, KB1P; Vice President Cameron Conover, AJ4TW; Engineering Chairman David Macchiarolo, AJ4TF; Financial Todd Smith, AK4TS; Member-at-Large Fred Lomax, KV4PI; and Secretary Greg Spencer, KG4UQV.

Tom gave an update on the 501(c)3 proposal he is preparing. David made a motion to bring the proposal to the membership at the next general meeting for approval, Cameron seconded, all in favor and the motion carried.

Cameron said he has Bob Gusek, NC4RG, lined up to do a presentation on 3D printing for the April meeting. Todd highlighted the results of the survey he did recently about presentation ideas.

The board discussed whether to hold the May meeting at the GARA picnic or to hold a separate meeting on the following Monday which is Memorial Day. Tom made a motion to bring this to the membership at the April meeting, Cameron seconded, all in favor and the motion carried.

The instructions for Form 1023 give examples of acceptable Purpose Statement and Dissolution Clause which the Board used to satisfy the IRS requirement. The attached copy of GARA's proposed Amended Articles of Incorporation that contains these changes (all changes in the attachments are underlined and italicized)

In addition the board added at the end of 3(d) the following statement "and provide for the education, training, and experience necessary to provide for the expansion of a qualified amateur radio pool". This statement will allow GARA to link our 501(c)(3) application to our Articles of Incorporation and gives



the application a better chance of approval. (This change is also underlined and italicized in the attachment) Before the IRS will accept the GARA's Amended Articles of Incorporation they have to be certified by the Secretary of State of NC. North Carolina's state law requires all amendments to an organization's Articles of Incorporation must be approved by its members before the Secretary of State can certify the document. During the April 28, 2014, General meeting I will brief GARA's proposed Amended Articles of Incorporation to the members present for their approval.

Below is a copy of GARA's proposed Amended Articles of Incorporation. Please read the following and if you have any questions, please ask them during the briefing.

#### ARTICLES OF INCORPORATION OF GREENSBORO AMATEUR RADIO ASSOCIATION, INC.

The undersigned, being of the age of eighteen years or more, does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a nonprofit corporation under and by virtue of the laws of the State of North Carolina:

- 1. The name of the corporation is Greensboro Amateur Radio Association, Inc.
- 2. The period of the corporation is perpetual.
- 3. The purposes for which the corporation is organized are:

(a) Exclusively for charitable, educational and scientific purposes under section 501(c)(3) of the Internal revenue Code or corresponding section of any federal tax code;

(b) the fostering and promotion of intercommunication by electronic means for the personal benefit of the members and without pecuniary gain;

(c) the relaying of messages by radio without charge;

(d) the promotion of interest in amateur radio communication, experimentation, and provide for the education, training, and experience necessary to provide for the expansion of a qualified amateur radio pool;

(e) the advancement of the radio art; and

(f) to engage in any lawful act or activity for which corporations may be organized under 55 of the General Statutes of North Carolina.

4. Upon the dissolution of this organization, assets shall be distributed for one or more exempt purpose within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code,

or shall be distributed to the federal government or to a state or local government, for public purpose.

5. The address of the initial registered office of the corporation in the state of North Carolina is 2205 Red Forest Road, Greensboro, Guilford County, North Carolina; and the name of its initial registered agent at such address is Morris T. Jeffreys.

6. The number of directors constituting the initial board of directors shall be nine (9); and the names and addresses of the persons who are to serve as directors until their successors qualify under the by-laws and be elected are:

#### Amendments to the Articles of Incorporation

1. The following Amendments to The Greensboro Amateur Radio Association's Articles of Incorporation were recommended by Board of Directors and approve by the membership as required Chapter 55A, North Carolina Nonprofit Corporation Act, at the General Meeting held on \_\_\_\_\_\_, 2014.

a. Paragraph 3(a) statement was added. The new statement reads as follows, "Exclusively for charitable, educational and scientific purposes under section 501(c)(3) of the Internal revenue Code or corresponding section of any federal tax code,"

b. Paragraph 3(d) statement was changed as follows: "the promotion of interest in amateur radio communication, experimentation, and provide for the education, training, and experience necessary to provide for the expansion of a qualified amateur radio pool,"

c. Paragraph 4 was added: The new paragraph reads as follows, "Upon the dissolution of this organization, assets shall be distributed for one or more exempt purpose within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government, for public purpose."

#### Ratification

Be it known by all who shall see these presents that these Article of Incorporation have been duly accepted by the members of the Greensboro Amateur Radio Association sitting in meeting on this\_\_\_\_\_\_\_the day of \_\_\_\_\_\_\_in the year\_\_\_\_\_\_A.D. and, at the direction of the members, the currently elected officers do hereby set forth their signatures upon which these Articles and By-Laws shall become effective.

## **From the President's Shack**

In my January's President's letter I stated, that during the year the membership will see some changes in the way GARA supports its membership and cuts its operation costs. During the past four months the board has been working on (but not limited too): becoming a certified as tax Exempt Corporation; establishing a way the membership can pay dues on line; and reducing the club's combined phone and internet bill.

Although preparing the paperwork for filing the 501(c)(3) certification has taken longer than I thought, we are making progress. The paperwork is about 90% complete. The next step in the process is to amend GARA's Articles of Incorporation. The IRS requires two statements be added to GARA's original Articles of Incorporation before they will consider GARA's 501(c)(3) application. Once GARA amends the articles, they have to be certified by the Secretary of State of NC. The state of North Carolina requires that the amended Articles of Incorporation be approved by GARA's General Membership before they will certify the amended Articles of Incorporation. I will present the board-approved, amended Articles of Incorporation to the general membership for approval during this month's meeting.

The Board has established a PayPal account for GARA and is in the process of placing a PayPal link on our web site. In the near future, the membership will be given the opportunity to; pay dues, renew/join their ARRL membership, and pay picnic fees on line.

The board has replaced Bellsouth/AT&T's phone line with Basic Talk resulting in an average savings of over \$40 per month.

### **Engineering Update for April, 2014**

Wow. That's all I can say about this winter. I think it's finally gone! At this writing (Sunday April 13th) the temperature is close to 80F. It's hard to believe that just 6 weeks ago it was snowing. I guess the groundhog was right.

#### **UHF (D-STAR) REPEATER**

There is a lot to report on the D-Star repeater. As I reported for the last few months, the engineering committee has received several reports on the D-Star repeater that the output power also seems lower than normal. This got worse over the course of the last couple of months.

A little bit of background: the D-Star repeater uses a modified GE MASTR-II continuous duty UHF power amplifier (nominally capable of 100 watts). It has 4 stages of gain on the preamplifier which raises an input power of around 2 watts up to 40 watts. This 40 watts is split 4 ways using a Wilkinson splitter and applied equally to 2 pairs of RF power transistors set up as 4 parallel class C amplifiers. The outputs of each of the 4

transistors is fed into another pair of Wilkinson combiners that combines the outputs of the 2 pairs of transistors into the final amplifier output (which then is fed to the duplexer and the antenna).

Finally, Arch, KT4AT, was able to get to the site and examine the repeater along with Roy, N4BYU; Tom, KB1P; and Layman, KK4LLY (I was on business travel that day). What they found was a blown capacitor in the power amplifier, along with at least one bad RF power transistor that caused the output combiner resistors to overheat.

Here is the section of the preamplifier driver where the

capacitor "was". All that was left was some black residue on the board, there was nothing left of the capacitor! This portion of the amplifier schematic shows the location of the blown tantalum capacitor. It is on the power input rail that supplies the 40 watt driver output transistor collector. It is the first thing that an incoming





The 100 watt power amplifier, as previously mentioned, has 4 matched RF power transistors, feeding 2 pairs of 2-port Wilkinson combiners. One of the transistors failed, putting that pair of transistors out of balance and overheating the isolation resistor in the combiner (in normal operation, there is no power dissipated in the resistor). Once that pair was down, the lack of power put stress on the downstream combiner that combined the outputs of the two pairs, and that resistor also overheated.

This portion of the amplifier schematic shows the location of the power transistors and the overheated combiner resistors.

Arch replaced the power amp on the

repeater with a spare that he had available, which got the repeater back up and running at full power.

The club's power amp has been repaired, with a replacement capacitor, new combiner resistors, and 4 new MRF646 UHF power transistors.

Repaired power amp with new transistors and combiner resistors:

After putting it back together, we keyed it up using an IC91 D-Star HT, and were pleased to see over 100 watts output!

Arch plans to do some longevity testing on the unit by keying it up for 8 continuous hours to make sure that there are no other weak components in it. If this checks out, we will swap this amp back into the repeater at a future date.





#### **VHF REPEATER**

From time to time, we have received reports of interference being heard on the input of the VHF repeater, and have heard it myself. Those of you who have been around for a while know that this happens periodically, and we have never been able to track down the exact source. A few days ago, I was mobile, and talking with another ham who happened to be located not far from me in High Point. I heard

some crackling on his signal, so I switched my radio to "reverse" (this means listening on the repeater INPUT frequency, instead of the normal output frequency). I could hear the other station, but more importantly, I could also hear the similar crackling on the repeater input. This suggests that the interference was coming in on the repeater input.

#### NEW EQUIPMENT

I have installed two Tripp-Lite ISOBLOK plug in surge suppressors, one on each repeater cabinet. The VHF repeater was plugged into a questionable device that belongs to the site owner, the D-Star repeater did not have any extra surge protection other than that provided by the UPS in the cabinet (the power amp's power supply is NOT connected through the UPS). I hope this additional measure of protection will prevent any future power surges from reaching our equipment.

#### NEW PROBLEM REPORTING SYSTEM

The club has been working on an on-line problem reporting system that will be available to members to submit reports of repeater operation. Watch for this coming soon to www.w4gso.org
