


Where has the year gone? It is August already. Before we know it, Halloween, Thanksgiving, and Christmas will be here.

## Info from ARRL

### ARRL ROANOKE DIVISION MEMBERS

### VANITY CALL SIGN FEE GOES UP AUGUST 23!

The new FCC regulatory fee of \$16.10 to apply for an Amateur Radio vanity call sign will go into effect Friday, August 23, when the new regulatory fee schedule will appear in the Federal Register. Earlier this year the FCC had proposed upping the vanity call sign fee from its current \$15 to \$15.20, but in the Report and Order in MD Docket 13-140, released August 12, the Commission offered no explanation for the higher fee.

In another change, starting in FY 2014, the FCC will require that all regulatory fee payments be made electronically.

The R&O ordered a broad schedule of new fees and waived the usual 30-day waiting period following Federal Register publication, because it feared there would not be time for FY 2013 fees to become effective before the start of the new federal fiscal year on October 1.

The FCC says it expects \$230,230 in revenue to cover the costs of administering the vanity call sign program. It anticipates 14,300 vanity call sign applications.

# **Repeater Etiquette**

Recently GARA's board of has heard some complaints about hams using the club' 145.150 repeater. The complaints range from hams dominating the repeater, hams not ID'ing, and the most serious complaint is hams using profanity on the repeater. We will state now, "Profanity will not be tolerated on this repeater". If you hear profanity on this repeater please make an on the spot correction by politely reminding the offending ham that profanity is not allowed per FCC rules. In most cases the ham will apologize, if he/she does not stop, do not argue with them, make a note of their call sign, time, date and give this information to a club official. The club will



take appropriate action against the ham, up to and including reporting him/her to the FCC .

Let's talk about the other complaints; hams dominating the repeater, and hams not ID'ing. The most command offense is not ID'ing. FCC rule requires hams to ID every 10

might the most command offense is not ID might of the requires mains to ID every to minutes and when you leave the QSO. So if your QSO lasts for over 10 minutes you need to ID (send your call sign) and every 10 minutes thereafter during the QSO. So if your QSO lasts for 35 minutes you will need to ID 4 time (every 10 minutes and when you sign off). I have gotten into some very interesting QSOs and have forgotten to ID, however the ham I was talking to ID'ed by sending his call sign and adding the remark for ID. This was a polite reminder by the other ham that I needed to ID. Some time we just have to remind each other to ID. Fortunately the repeater will remind us too. It will send its ID by Morse code every 10 minutes. When you hear the repeater ID, it's time to ID as well.

The other complaint is hams dominating the repeater. This happens when the hams in the QSO do not allow enough time between their conversations for other hams to join their QSO. There are no FCC rules about this complaint. However, there is something called repeater etiquette. This is a system of unofficial common sense rules that have developed over time, and when they are followed they allow for orderly QSOs over repeaters. I will review some of these unofficial rules. For the newly licensed ham this may be the first time you see these rules. For hams who have been licensed for a while it will be a refresher. I will review them in this order:

What to do when you tune in to a repeater; How to enter a QSO; What to do when you are in a QSO.

When you tune into a repeater, the first thing you should do is listen. You should listen for at least 10-20 sec to ensure no one is using the repeater. If no one is using the repeater and you want to talk to another ham send his call sign than yours. Example: N4??? this is KB1P, if he is monitoring he will answer. If you do not care who you talk to just send your call sign KB1P and state "listening". If there is someone monitoring they may answer. If no one answers your call try again in a few minutes.

What should you do if after tuning into a repeater and during the 10-20 sec pause and you hear hams talking? To join the QSO you have to wait for a pause



in the conversation. There should be a pause after one ham passes the conversation to the other ham. It is during this pause you send your call sign. After you send your call sign you wait until one of the hams acknowledges you by sending your call sign. If they do not acknowledge your call sign try again during the next pause. They should acknowledge you.

When you are in a QSO and it is your turn to talk, do not press the PTT button until you hear the repeater drop. This will take a few seconds. For new hams, this is what "letting the repeater drop" means: you will hear the courtesy beep, and the transmitter will continue to broadcast without any audio for a second or so. This is known as the "squelch tail". Once the transmitter has stopped, then you can key up your radio. This allows two things to happen. The first, it will prevent the repeater from timing out, and second it gives other hams time to join the QSO.



The 145.150 repeater is our repeater and it is up to us to ensure that all hams using this repeater do so in an orderly. Do not be afraid to make a polite

correction. This is other hams teaching or reminding other hams. Some examples of corrections: "Hey Tom you should wait until the repeater drops before you key, maybe someone wants to join the QSO". If someone buts into the middle of QSO and it is not an emergency, call him/her and state, "It is customary to wait until there is a pause in the QSO before you join in". Or, just state, "Hang on for a minute, we will get back to you.

If we are allowed to continue to make mistakes without correction, how are we going to learn?

## **Congratulations! You Passed!**

Every month on the second Saturday, except in March when it is the third Saturday, W4VEC holds a testing session for those who live in the area. This provides an opportunity for individuals to be able to test for their amateur radio license or upgrade. Thanks to Roy Smith, N4BYU, and a group of volunteers, each month there are new or upgraded hams in our area.

In August, there was no one who passed their test(s) and earned either their Technician, General or Extra class license.

## Pending Amateur Service Rule Changes Are Not on Back Burner, FCC Assures VECs

Speaking in late July at the 28th annual National Conference of Volunteer Examiner Coordinators (NCVEC) meeting, Bill Cross, W3TN, of the FCC's Mobility Division within the Wireless Telecommunications Bureau (WTB), assured attendees that pending proposals to modify the Amateur Service Part 97 rules are not on the back burner but still under review. FCC personnel addressing the teleconference were unable, however, to predict when the Commission would take action on the Notice of Proposed Rulemaking and Order (NPRM) in WT Docket 12-283.



Among the FCC proposals: Granting exam credit for expired and beyond-the grace-period licenses; shortening the grace period during which an expired ham ticket may be renewed; correspondingly revising the time a call sign remains unavailable to vanity applicants; and reducing the number of volunteer examiners needed to administer examinations. The docket also seeks comment on amending the rules to permit remote test administration and proposes allowing Amateur Radio stations to transmit certain emission types.

FCC Program Analyst Rebecca Williams of the FCC's Gettysburg Office told meeting participants that the FCC will not remove or conceal a licensee's name or address from its public database. She said she's received numerous complaints from licensees about their information being public. According to §97.23, licensees must provide a valid mailing address, but as Williams pointed out, that can be any US address where the licensee can receive mail, such as a work address or a post office box. Licensees can protect their privacy and remain within the rules, she said.

She also reminded her audience that since February 14, 2011, a radio amateur can serve as a trustee for only a single club and may not also be a club license trustee for another club. The rules further prohibit clubs from having more than one vanity call sign. Amateurs who served as trustees for more than one club, and clubs holding more than one vanity call sign before the change may continue to do so, she said.

NCVEC Chair Larry Pollock, NB5X, presided over the teleconference. ARRL VEC Manager Maria Somma, AB1FM, Assistant Manager Perry Green, WY1O, and Regulatory Information Manager Dan Henderson, N1ND, represented the ARRL VEC for the session. Representatives from 12 of the nation's 14 VECs took part in the meeting.
